**AUTHORIZATIONS:** I hereby (i) authorize the coaches, managers, trainers, directors, employees, or others acting as activity supervisors or vehicle drivers of Euro Youth Football Association ("EYFA"), also known as FA Euro New York, to act as my agent in connection with the Player's participation in the activities of EYFA, (ii) consent to medical, surgical or dental examination and/or treatment for the Player under whatever conditions are medically necessary and agree to pay the usual customary charges for such treatments or ambulatory care and (iii) authorize treatment and/or care of the Player at any medical facility or hospital and (iv) give permission for the Player to ride in a car, van, bus or other vehicle driven by a coach, manager, trainer, employee or other adult acting as activity supervisor or vehicle driver of EYFA and (v) give permission for the Player to be chaperoned and supervised by a coach, manager, trainer, employee, independent contractor or other adult acting as activity supervisor or vehicle driver of EYFA when the Player is on team trips or traveling with EYFA.

I understand that this release applies both to future and present injuries, damages, or losses, and is binding on the Player, the Player's guardians, and the Player's heirs, executors, and administrators. I understand that the Player may be photographed and/or videotaped during the activities of EYFA and hereby grant EYFA sole permission to use the Player's likeness in photographs and/or video on social media, in any and all of its publications, and in any and all other media.

**IMPORTANT INFORMATION:** All players are bound by the By-Laws and Rules and Regulations of EYFA. Copies of such rules are available from EYFA on the club's website. By signing this document and registering the Player with EYFA, you are indicating your agreement with the foregoing. All players and parents are knowledgeable that all registration costs are non-refundable.

## 2024/25 PLAYER CODE OF CONDUCT 1/2



Participation in FA Euro New York (the “Club”) is a privilege. All players must exhibit the necessary professionalism and maturity to be successful in this pursuit. The following Player Code of Conduct shall apply in all Club Events (as defined below). As a player of FA Euro New York, I agree to abide by the following Player Code of Conduct (this “Code of Conduct”):

- I will conduct myself, at all times, in an appropriate, professional, and sportsmanlike manner, and will treat all teammates, competitors, officials, coaches, staff members, and others involved in the Club and/or Club Events with courtesy and respect. As used herein, “Club Events” means any and all activities or events associated with the Club and/or a Club Team, or related to or occurring as a result of the Club and/or a Club Team, including, but not limited to, any training sessions, practices, scrimmages, matches, meetings, team meals, travel, lodging and/or charity events at facilities of the Club or at any other location.
- I will take no action (or omit to take any action) that causes (or may cause) public embarrassment for myself, the Club, the United Soccer Leagues or Major League Soccer, or any of their respective affiliates, or that brings (or may bring) myself, the Club, FA Euro New York, Uniter Soccer Leagues, Northeast Academy League or Major League Soccer, or any of their respective affiliates, into disrepute in the community.
- I will respectfully follow the instructions and requests of coaches, staff members, and other adults associated with the Club without hesitation or resistance.
- I will follow all applicable local, state, federal, and international laws while participating in Club Events.
- I will abide by all applicable event, facility, and tournament rules and will act in a manner that is respectful of the event that I am attending and its facilities. I will show respect for all event facilities by picking up after myself and disposing of trash as directed by the event or Club coaches and/or staff members.
- I understand that my appearance is a direct reflection of my team and the Club. Accordingly, for all Club Events, I will dress appropriately and in the manner required by Club coaches and/or staff members.
- I will, at all times, use language that is appropriate both on and off the field, while participating in Club Events and elsewhere. I will not use obscene language, gestures, or curse words. I will not use slurs, phrases, or gestures which denigrate, ridicule or mock a person or persons based upon, among others, their race, gender, sexual orientation, economic status, nationality, religion, country of origin, or political affiliation. I will not bully or haze any teammate or other person, whether involved with the Club and/or Club events or elsewhere, and I will immediately report any violations of this provision of the Code of Conduct by myself, my teammates or opponents, and coaches/staff to my coach if appropriate and/or a Club Director. Violations of this provision of the code of conduct are of the most serious nature and violators may be subject to, among others, a requirement to partake in appropriate sensitivity training, counseling, and/or community service programming, or suspension or dismissal from the Club.

## 2024/25 PLAYER CODE OF CONDUCT 2/2



- I will not steal, harm, or damage the property of others (soccer/training facility, hotel, lodging, mode of transportation, etc.) during any Club Event. I understand and accept that if I damage any property of others during any Club Event, I will be responsible for paying for any and all damages and repair costs that result from such damage.
- I will not intentionally injure or harm another teammate, referee, player, coach, or staff member ("person") during any Club Event.
- I will not, under any circumstances, possess or use any alcohol, tobacco, or illegal drugs, at any time, during Club Events. I will avoid situations where alcohol or tobacco use by minors and/or illegal drugs are present. If I am at a Club Event where alcohol or tobacco use by minors and/or illegal drugs are present, I will immediately notify Club coaches and staff members and leave the area if safe to do so.
- I understand and accept that if I am dismissed from the Club or a Club Event while traveling, I may be sent home immediately at my expense (or the expense of my parent(s)/guardian(s)) by whatever means is most convenient for the Club coaches and/or staff members.
- I understand that violating this Code of Conduct in any respect, implied or otherwise, may or will result in consequences, including, but not limited to, game time restrictions, game suspensions, hotel room restrictions, loss of personal privileges, imposition of monetary fines, and suspension and expulsion from the Club (and being sent home at the expense of my parent(s) and/or legal guardian(s), if I am suspended or expelled from the program while away from home). All punishment and penalties will be determined at the sole discretion of the Club coaches and are final and non-appealable. The Club reserves the right to amend, modify or otherwise supplement this Code of Conduct from time to time in the Club's sole discretion.
- I will play the game for the game's sake, and not just to please my parents or coach.
- I will be modest and generous when I win and gracious when I lose.
- I will respect the game of soccer and its laws, learn these laws and try to follow them, and play the game fairly.
- I will work for the good of my team and give my best effort at all times.
- I will show respect for the authority of the referee, even though I will sometimes disagree with his/her calls.
- I will show good sportsmanship before, during, and after games. I understand that soccer is a game and that the players on the other team are my opponents, not my enemies.
- I will conduct myself with honor and dignity and treat other players as I would like to be treated.
- I will help my parents and fans understand the laws of the game so they can watch and enjoy the game better. I will be sure they understand that dissent is not appropriate or permitted at league or tournament games.
- I will control my temper and not retaliate, even if I believe I have been wronged.



The United Soccer Leagues, Northeast Academy League, Major League Soccer (the "Leagues"), and FA Euro New York (the "Club") are committed to creating a safe, comfortable, and enjoyable training and match-day experience for all players and parents. We are also deeply committed to fostering an inclusive environment, free of discrimination and harassment. This Parent Code of Conduct addresses conducts that is inconsistent with these goals and detracts from the overall player development experience. The Codes of Conduct can be summarized in the following three principles: (1) Demonstrating a positive attitude; (2) Setting a good example; and (3) Maintaining good relationships with all youth soccer participants - including officials, opponents, and our own team's players, parents, and coaches.

### 1. DEMONSTRATING A POSITIVE ATTITUDE

Players, parents, and coaches are expected to show a positive, respectful attitude toward everyone involved in the sport. Criticism and disrespect for officials, opponents, coaches, or fans undermine the purpose of the sport and encourage behavior contrary to the spirit of the game and the mission of FA Euro New York.

### 2. SETTING A GOOD EXAMPLE

Each person associated with FA Euro New York is accountable for his/her own behavior at all times on or off the field of play. Parents, coaches, and other adults should remember that children learn by example - it is up to the adults to set good examples. FA Euro New York will not tolerate conduct that is detrimental to the sport, the participants, or the community. Such conduct includes Vulgarity by coaches, players, or parents; harassment or belittling of officials, coaches, or players; verbal abuse, threats, or physical violence toward anyone before, during, or after a match; and the taunting of opposing players, coaches and parents. We require thorough self-restraint from all participants - both players and adults. Teams must exercise appropriate control over those who fail to control themselves.

### 3. MAINTAINING GOOD RELATIONSHIPS

**Officials** - The referee's job is a difficult one. All referees are human and they do make mistakes. Parents or players who believe their team has been treated unfairly or has been assigned an unqualified referee should speak to their coach after the game. Coaches should inform the appropriate league or tournament officials about blatant officiating problems. In accordance with FIFA laws, verbal abuse toward a referee can result in a red card and ejection for the player, coach, or parent. Referees have the authority to suspend play if a coach does not control his players and parents/supporters.

**Opponents** - Players and coaches are required to maintain a sense of fair play and be respectful of opposing players, coaches, and fans at all times. Sportsmanship begins with respect. Without it, the positive competitive environment, which should be a perfect classroom for learning the values of soccer, is completely undermined. Occasionally we will encounter opponents who do not share our values and high standards. If we allow ourselves to be drawn down to their level, we will have lost regardless of the final score.

**Our Own Team** - In an environment where our children are competing not only against other teams but also frequently against each other, it can be difficult to control jealousies and rivalries. A successful team resembles a family in that members put their own needs second, behind the greater good of the team. Great care must be taken not to undermine the coach's authority. As in most cases, parental example is all-important.

As a parent, you play a special role in the development of your daughter or son, and of his/her teammates. Your encouragement and good example will do more to ensure good sportsmanship and self-discipline than any other influence. The other team is the opponent, not the enemy, and should be treated with respect. While winning is important, playing well and fairly is the essence of the game.

## 2024/25 PARENT CODE OF CONDUCT 2/3



SUPPORT YOUR CHILD. Support your child by giving encouragement and showing interest in his/her team. Help your child work toward skill improvement and good sportsmanship in every game. Teach your child that hard work and an honest effort are often more important than victory.

BE SUPPORTIVE AND YOUR CHILD'S BIGGEST CHEERLEADER. Children learn more by example than by criticism. Work to be a positive role model, and reinforce positive behavior in others. Applaud good plays by others on your child's team as well as good plays by the opposing team. Do not criticize any child's performance from the sidelines. Accept the results of each game. Teach your child to be gracious in victory and to turn defeat into victory by learning and working toward improvement.

DON'T BE A SIDELINE COACH OR REF. Refrain from coaching or refereeing from the sidelines. Parents who shout or scream from the sidelines often give inappropriate advice at the wrong time. The coach should be the only sideline voice. Remain well back from the sidelines and within the spectator area. You and your child will both enjoy the game more if you put some emotional distance between yourself and the field of play. Officials are symbols of fair play, integrity, and sportsmanship - Do not openly question their judgment or honesty.

DEMONSTRATE A POSITIVE ATTITUDE TOWARD YOUR OPPONENTS AND THEIR FAMILIES. Opponents are not enemies. Take care to show good hospitality at home and to represent FA Euro New York in a positive way when playing other clubs. Never allow yourself to be drawn into a verbal disagreement with opposing parents or coaches. No one has ever regretted letting "cooler heads prevail."

REMEMBER THAT YOUR CHILD WANTS TO HAVE FUN. Your child is the one playing soccer, not you. Children must establish their own goals - to play the game for themselves. Take care not to impose unreasonable demands on your child. Let your children experience the fun of playing as well as the challenge of excelling.

### GENERAL EXPECTATIONS OF FA EURO NEW YORK PARENTS:

- Not criticize the referee openly or directly, during or after games. Any criticism shall be done in writing, sent to my coach and/or my club representative, not verbally.
- Give only positive feedback to players.
- Cheer at all games within the spirit of fair play and shall do our best to cheer the effort regardless of the outcome. We will be mindful in a "lopsided" game where cheering our own "winning" team might be misunderstood.
- Do our best to teach our players to become students of the game.
- Show the quality of our sportsmanship during and after each game and help our child remember to thank the referee after the match without regard to the result.
- Do our very best to have our child prepared for every game.
- Support the learning efforts of the players, the coaches, and the referees by demonstrating our patience.
- Understand that improper behavior at a game may result in a parent being asked to leave the field by the referee, the FA Euro New York, or a club official so the coach does not receive a yellow card caution or a red card ejection due to the action of the parent spectator.
- Leave the coaching to the coach during the game. We shall not give our child instructions during the game.
- Understand that the leagues can, and will if necessary, suspend our individual privilege to watch our child play should we behave in a manner that is rude or otherwise offensive.
- Agree to do our best to have as much fun watching the game as the players should have playing the game.



### 48 HOUR RULE

The 48 Hour Rule is a rule that is in place to help keep the peace between the coach and parents. The rule is simple. Parents are not allowed to approach the coach about issues until 48 hours after the competition.

Reasons for the rule:

- To allow the parents to calm down after the issue has developed
- Allow the coach to calm down after the competition
- Give parents and coaches time to think about the problem
- To prevent any unnecessary acts or scenes in front of players and other parents
- Calmer heads will prevail
- To stop any embarrassing moments in front of the Players or child

The hope is that time to think about the issues will help to solve the problem in a positive manner and the right resolution

Sometimes in the heat of the moment parents and coaches say things that they really don't mean. This can hurt the player or team because things were not handled correctly. The parent & Coach relationship is important, but the overall decisions should be based on what is best for the team and players. The rule is in place to help protect the players and team.

### VIOLATIONS OF THE PARENT CODE OF CONDUCT

Violations of the Parent Code of Conduct may result in:

- A Parent being suspended and/or removed from a game/tournament by a referee for misconduct.
- A Coach being suspended and/or removed from a game/tournament by a referee for misconduct.
- A Player being benched by the team's coach for parent misconduct before, during, or after a game.
- A Member or Family could be released from the Club.
